## NOTICE OF VACANCY

### in the office of Parish Councillor for Hutton Parish Council – West Ward

**NOTICE IS HEREBY GIVEN** that a casual vacancy is deemed to have occurred in the office of Councillor for Hutton Parish Council following a resignation.

Rule 5 of the Local Elections (Parishes and Communities) (England and Wales) Rules 2006, provides that on a casual vacancy occurring in the office of **Parish** councillor, an election to fill the vacancy shall be held if within fourteen days\* after the date of this notice (i.e. **no later than 11 February 2025**) has been given in accordance with section 87(2) of the Local Government Act 1972, notice in writing of a request for such an election has been given to the proper officer of the council of the district within which the **Ward** is situated by **TEN** registered electors for the **Ward**.

If a request for an election is not received by the above deadline, then Hutton Parish Council will make arrangements to co-opt a person to fill the vacancy as soon as practicable in accordance with the Local Elections (Parish and Communities) Rules 1986.
