As you know traffic counts are approximately 80% lower than historic levels. With this, for the foreseeable future we will not be requesting that new traffic counts to be undertaken, there current values are meaningless. I am aware that lock down started 23<sup>rd</sup> March, however the first cases were noted 28<sup>th</sup> Feb. Any data collected between 28<sup>th</sup> Feb-23<sup>rd</sup> March will need to be validated as being acceptable by the applicant and their consultant. At matters currently stand traffic data collected post 23<sup>rd</sup> March 2020 will NOT be accepted by LCC as local highway authority.

It is likely that a consultant may ask for your advice on when traffic data will be acceptable. In response, I can indicate that Traffic data is being continuously monitored at a few sites within Lancashire. This and other sites will be used to determine when new traffic data will be acceptable in Lancashire. It may be the case that the new normal will be different to the historic, but at this stage no one knows. Once we are satisfied that traffic levels have normalised we will accept new traffic data. If a consultant presents data that is biased, he is using this at his own risk and he should be made aware of this.

For Transport Assessment's and Statements analysis will need to apply existing traffic counts, with a suitable level of traffic growth using the traditional approach i.e. (Tempro), no discounting will be acceptable if the consultants anticipate their thoughts on the new norm.

We will however consider the use of engineering judgement to infill where no data is available but requires highway officer support and all documentation must include a clear audit trail of all data used and supporting analysis which can be examined and be scrutinised by others (i.e. at a public inquiry). There are a 1001 variations on how this can be done in an acceptable way.

If you are unsure on a consultants approach and their engineering judgement please ask.
