This statement must be submitted **no later than three months** beginning on the day on which the draw (or last draw) in the lottery took place. It must be signed by two members of the Society appointed in writing for that purpose by the Society, or its governing body if applicable, **and** accompanied by a copy of that appointment. Under Section 262 of the Gambling Act 2005 a non-commercial society commits an offence if:

- 1. A lottery is promoted at any time it is not registered with the Local Authority
- 2. The society fails to submit records [returns]
- 3. The society provides false or misleading information on a return form.

A person guilty of the above offences shall be liable on summary conviction to:

- 1. Imprisonment for a term not exceeding 51 weeks
- 2. A fine not exceeding level 5 (currently £5,000) on the standard scale
- 3. Both.
